Dean Grasso called the meeting to order at 10:00am.

## I. Approval of Minutes

The minutes of the March 31, 2016 meeting were approved.

# II. Administrative Board Action Items

### A. Program Action

- a. At the request of the College of Humanities and Social Sciences, a Request to Plan a PhD program in International Relations and Security (presented by Dr. Heidi Hobbs, Dr. Richard Mahoney, and Dr. Traciel Reid) was approved with minor revisions to address the Board's comments.
- b. At the request of the College of Humanities and Social Sciences, a proposal to create a Graduate Certificate in Nuclear Nonproliferation Science and Policy (presented by Dr. John Mattingly) was approved with minor revisions to address the Board's comments.

### B. Course Revisions (usually taken as a consent agenda)

A motion was made to approve items a through i as consent agenda items. The motion passed and the items were approved.

- a. At the request of the College of Humanities and Social Sciences, a proposal to revise the course CRD 790—Scholarly and Professional Paths in Disciplinary and Interdisciplinary Research by updating the course information (presented by Dr. Deanna Dannels).
- b. At the request of the Department of Electrical and Computer Engineering, a proposal to revise the course ECE 719—Advanced Microwave Design by updating the course content (presented by Dr. Mohamad Bourham).
- c. At the request of the Department of Business Management, a proposal to revise the course MBA 519—Enterprise Risk Management Practicum by correcting the contact hours (presented by Dr. Donald Warsing).
- d. At the request of the Department of Business Management, a proposal to revise MBA 569—Consumer Innovation Practicum by correcting the contact hours (presented by Dr. Donald Warsing).

- d. At the request of the College of Natural Resources, a proposal to create the course NR 511—Managing Natural Resources in an Arena of Conflict (presented by Dr. Joe Roise) was tabled pending a consultation with the Communications graduate program.
- e. At the request of the College of Natural Resources, a proposal to create the course NR 512—Land Use Policy and Management (presented by Dr. Joe Roise).
- f. At the request of the Department of Business Management, a proposal to create the course MBA 502—Managerial Accounting for Decision Makers (presented by Dr. Donald Warsing) was approved.

A motion was made to approve items g through j as consent agenda items. The motion passed and the items were approved.

- g. At the request of the Department of Business Management, a proposal to drop the course MBA 529—New Firm Financing (presented by Dr. Donald Warsing).
- h. At the request of the Department of Business Management, a proposal to drop the course MBA 551—Services Management and Marketing (presented by Dr. Donald Warsing).
- i. At the request of the Department of Business Management, a proposal to drop the course MBA 552—Managerial Issues in Organizational Culture (presented by Dr. Donald Warsing).

- j. At the request of the Department of Business Management, a proposal to drop the course MBA 557—Management Consulting (presented by Dr. Donald Warsing).
- k. At the request of the Department of Social Work, a proposal to create the course SW 524—Portrayals of Social Welfare in Urban Life (presented by Dr. Deanna Dannels) was approved.
- I. At the request of the College of Veterinary Medicine, a proposal to create the course VMB 952—Specialized Problem Solving in Veterinary Medicine (presented by Dr. Sam Jones) was approved.

#### III. New Business

a. Approval of a bulk drop of graduate courses that have not been offered in over three academic years.

Dr. Peter Harries explained that the posted spreadsheet highlighted in red the courses that have never been taught or have not been taught in the past 3 years. Ms. Melissa Nosbisch contacted all colleges and departments about the courses, and Ms. Brittany Mastrangelo confirmed that the courses will remain in SIS and can be reactivated at a later date (as is the case for all dropped courses). This bulk drop action removes the course from the public course catalog.

A motion was made to approve this bulk drop of courses. The motion passed and the highlighted courses will be dropped.

## IV. Information Items

- a. Report from GSA (presented by Ms. Jessica Nash). No report since Ms. Nash was not present.
- b. Report from Faculty Senate (presented by Dr. Helmet Hergeth).

Dr. Hergeth explained that the Academic Policy Committee has discussed the workload of the Undergraduate Courses and Curricula Committee (UCCC) and the Council on Undergraduate Education (CUE), seeking to combine the two committees, but after more investigation will not recommend any change.

The Faculty Senate has also discussed changes the alma mater, specifically the reference to "Dixie." After discussion, the Faculty Senate's Executive Committee decided that it was not the appropriate governing body to change the song, and deferred to the student body and alumni.

The Faculty Senate has also discussed the proposed changes to the alcohol and drug policies.

- c. Dean Grasso will not be at the next scheduled meeting. She will be in Washington, DC educating legislators about graduate education. She has been invited as a participant in the Council of Graduate Schools Advocacy Group.
- d. Dean Grasso reminded everyone that Graduate Education Day at the North Carolina legislative building is May 24, 2016. NC State is providing Howling Cow ice cream at 10:30am.
