Dean Grasso called the meeting to order at 10:00am.

I. Approval of Minutes

The minutes from the August 25, 2016 meeting were approved.

II. Administrative Board Action Items A. Program Action

- a. At the request of the Poole College of Management, a proposal to establish a dual degree partnership for the Master of Accounting program with Campbell University's Norman Adrian Wiggins School of Law Juris Doctor program (presented by Dr. Kathy Krawczyk) was approved.
- b. At the request of the College of Sciences, a proposal to edit the degree code for the Master of Financial Mathematics (presented by Dr. Jo-Ann Cohen) was approved.
- c. At the request of the College of Veterinary Medicine, a request to discontinue the Master of Specialized Veterinary Medicine (MR) program (presented by Dr. Sam Jones) was approved.

College of Sciences

III. New Business

a. Discussion of revisions to Graduate Handbook sections 1.7 and 1.8 Administrative Board of the Graduate School (presented by Dr. Peter Harries).

Dr. Harries explained that this document was drafted based on feedback at the end of last year's meeting. He explained that the biggest change is that each college may have up to 2 members serving on the Board.

Any suggested revisions or comments should be sent to Dr. Harries. He will modify the document and bring back this item at a later date for approval by the Board.

b. Discussion of old courses applying to graduate student grade point average (GPA), REG 02.45.02 Grades and Credit in Graduate Courses (presented by Dr. Peter Harries).

Dr. Harries explained that if a student begins a program but does poorly, terminates the program, then returns years later to complete that degree, the low grades factor into the current GPA. This can negatively affect the student as it becomes difficult to meet the minimum GPA requirement. Dr. Harris proposes that the Graduate School initiate a policy that waives GPA from old courses taken outside of the current graduate program, since those older courses are unrelated to the current program of study.

Dr. Louis Hunt explained that at the undergraduate level GPA's can be reset when a student enters a new program. There are various tools at our disposal if we want to initiate a similar "grade amnesty" policy for graduate students.

Dr. Harries stated that the Graduate School will draft a policy revision to address this issue. Any suggestions or comments should be sent to Dr. Harries and this item will be brought back to the agenda at a later date for approval by the Board.

c. Discussion of whether or not concentrations should have different CIP codes than the major program (presented by Dr. George Hodge) was postponed for a later meeting.

IV. Information Items

a. Report from Graduate Student Association (GSA) (presented by Ms. Jessica Nash).

Ms. Nash announced that GSA sent 2 representatives to Legislative Action Days in Washington, DC in early September to discuss issues related to graduate education. Topics discussed included graduate student health insurance and student visas. Students are concerned about proposed changes to health insurance. Dean Grasso noted that there are committees on campus concerned with this, as well.

Ms. Nash announced that there is a new GSA subcommittee to discuss student fees, particularly college-specific fees. This subcommittee was initiated by GSA representatives, not just the executive board, which illustrates increased graduate student involvement in the organization.

b. Report from Faculty Senate (presented by Dr. Helmet Hergeth).

Dr. Hergeth explained feedback from the Faculty Senate about Dean Grasso's presentation at a recent meeting. Dean Grasso's presentation was about faculty as mentors for graduate students.

Dr. Harries explained that it is important to identify the faculty members who are not serving as good mentors, for example by not moving students through the program in a timely manner, because poor mentoring can be detrimental for students.

Dr. Dannels mentioned that she shared the performance data provided by the Graduate School with programs in the college and that she received positive responses. She suggests the approach, "here is the data, do what you want with it" so the programs can assess the neutral data and they move forward as they desire. This way, the Graduate School is providing data, but is not telling the programs how to conduct business within their programs.

c. Report of the online withdrawal system (Dr. Lian Lynch).

Dr. Lynch announced that the online withdrawal process is live. The screenshots were posted for all board members to see. She explained that the Leave of Absence request is embedded in this process and that the Graduate School hopes to include the termination process eventually. She noted that you can check the status of and action at any time. Beginning Monday, October 3, DGPs will receive a weekly email of withdrawal notifications listing approvals and denials. Contact Dr. Lynch with any questions.

d. Announcement of the Peer Writing Program, https://grad.ncsu.edu/peer-writing-groups/ (presented by Dr. Peter Harries).

Dr. Harries announced that this is a new program attempting to form writing groups for students from various areas. A trained peer will lead each workshop. Dr. Harries suggested that this will be a recurring opportunity.

e. Announcement of the Spring/Summer 2017 Doctoral Dissertation Completion Grants application deadline of October 14, 2016, https://grad.ncsu.edu/students/fellowships-and-grants/opportunities/doctoral-dissertation-completion-grants/ (presented by Dr. Peter Harries).

The target audience is students who are struggling with finishing the dissertation and need the additional assistance.

f. Announcement of the Southern Regional Education Board (SREB) Doctoral Scholars Program application deadline of March 1, 2017, https://grad.ncsu.edu/wp-content/uploads/2016/08/SREB Doctoral Scholars Description.pdf (presented by Dr. Peter Harries).

Dr. Harries announced that this is a scholarship program designed to create more PhD students from underrepresented minority status. NC State is funding 5 scholars per year. Contact Dr. David Shafer at the Graduate School with any questions.

g. Announcement of changes to the Graduate Catalog, http://www.grad.ncsu.edu/catalog/default.asp (presented by Ms. Melissa Nosbisch).

Ms. Nosbisch announced that the Graduate Catalog page will soon display information for each graduate program, rather than the current display of departments. DGPs will soon be prompted to update their program page. The Board had no concerns about this transition.

h. Dr. Cohen mentioned the racial climate town hall meeting tonight at Stewart Theatre and encouraged all to attend.
