Master of Art + Design Degree Name Change Request Fibers and Fashion Studies Concentration

Description:

The intent of the proposed name change is to more accurately reflect the existing and future academic focus of the concentration and the existing course offerings and faculty expertise available to students. The concentration name change, from Fibers and Surface Design to Fibers and Fashion Studies, does not require significant change in curriculum or course offerings. The core required courses have not been altered. The concentration elective offerings have been expanded to match the faculty expertise, align more closely with the academic mission of the unit and broaden possible student research areas.

The Fibers and Fashion Studies Concentration would provide a pathway for students to study fashion, fibers-textile design and theory at a graduate level within the context of a multi-disciplinary Design College. Knowledge of historical precedent, materials, digital and traditional hand processes and design thinking or problem solving makes our graduates assets to the fashion, costume, textile design and design industries. Potential student research areas of focus include the following: fashion, accessories, textile products, quilts, conceptual fiber installation, print design, embroidery and surface design.

Objectives:

- Graduate students will be able to produce research that is consistent with master level inquiry.
- Graduate students will be able to demonstrate an understanding of theoretical frameworks and systematic research related to the design process in support of project decisions.
- Graduate students will be able to demonstrate both research abilities and technical proficiency through the creation of innovative products and/or conceptual art pieces.

College of Textiles

The Department of Art+Design has had a lengthy relationship with the College of Textiles. This relationship includes the Anni Albers five year undergraduate joint degree (established in 2000) offered by Art+Design and the College of Textiles, Department of Textile, Apparel Technology and Management. An agreement was reached between the two colleges in 2009, stating that the "College of Design faculty will take the lead for the MS Degree with active College of Textile collaboration. We understand that many options will be considered including: an entirely new degree, a modification of a current College of Design degree with a significant textiles concentration, and/or a modification of an existing College of Textiles degree with a significant design concentration". This proposed concentration title change is consistent with the intent of this agreement. College of Textiles is currently offering fashion at the undergraduate level. The curriculum for the Fibers and Fashion Studies Concentration allows for the inclusion of course work from other colleges including the College of Textiles, depending on the focus of the master project. At this time, there are no courses offered by the College of Textiles built into the curriculum. It is intended that this concentration may be of interest to graduates of undergraduate textiles programs if they wish to further explore design issues in fashion at a graduate level.
