GENERAL INFORMATION

The I-20/DS-2019 cannot be issued until this form has been approved. Upload page 2 of the CFR and bank statement to the "International Applicants Only" section of your online application by logging in using your PIN and password. https://app.applyyourself.com?ID=ncsu-grad. The passport's identification page should also be uploaded since the I-20/DS-2019 will match the name as it appears there. Processing takes 3-6 business days.

ALL INTERNATIONAL STUDENTS ARE REQUIRED TO MAINTAIN HEALTH INSURANCE THROUGHOUT THE DURATION OF THE I-20/DS-2019. To do so, the student must either purchase the mandatory hard waiver University health plan or waive out of this plan by showing proof of an alternative plan that meets a set of required criteria. J students must also show proof of insurance for their dependents valid for the duration of the principal's DS-2019. Students on a Teaching or Research Assistantship will have their health insurance covered by the Graduate Student Support (GSSP). Sponsorship by non-immigrants in a visa status which does not allow employment may not be acceptable and will require further inquires.

FINANCIAL GUIDELINES

Bank statements must be in English and include the bank's official stamp, printed name, title and original signature or be on official bank letterhead. Date of issuance must be indicated on the statement or letter showing to be within 6 months of application submission. General letters of statements from Chartered Accountants, Solvency Certificates, value assessments of properties, stocks/investments, salary information, mortgages, insurance policies, deposit slip or passbooks are NOT acceptable.

ALL applicants must be able to demonstrate at least \$47,037 in support-\$26,243 for tuition, \$20,794 for living expenses (9 months for F-1) which includes Rent, Fees, Food, Books and Personal expenses. J-1 students must show at least \$53,968 in support-\$27,725 for living expenses (12 months for J-1) per each year as listed on the DS-2019. Part-time or full-time employment during summers should not be expected to be a significant means of support. Please keep in mind that this is an estimate calculated well in advance of the actual start of the semester and these estimates are subject to change. An increase per year of 4-8% can be expected. **Applicants to premium programs as listed in section II below will demonstrate additional funding due to higher tuition rates/fees.**

Applicants who will receive an assistantship award should upload their assistantship letter in the CFR portion of their online application for review. If the award does not cover the entire international financial requirement, the difference in funding should be demonstrated on a CFR before admission can be processed. Most assistantship awards will include tuition and university health insurance; however a monthly stipend of at least \$1,995 is necessary to meet the minimum requirement.

An applicant who will be financially sponsored by his/her employer, home government or university, must provide an official letter of support, with the current date and a signature. The letter must explicitly list the amount awarded for living expenses. The letter should also include the applicant's name, academic program and duration of award (2-3 years for a Master's degree and 4-5 for a Doctoral degree).
