## MINUTES

Dr. Harries called the meeting to order at 10:00 am.

## I. Approval of Minutes

The minutes of the August 30, 2018 were approved.

## II. Administrative Board Action Items

## A. Program Actions

a. At the request of the Department of Science, Technology, Engineering, and Mathematics (STEM) Education, a proposal to reorganize the Master of Education programs in that department (presented by Dr. Karen Hollebrands) was approved.

Dr. Hollebrands explained that the department currently has $3 \mathrm{M} . E d$. program and wishes to consolidate them into one program titled M.Ed. in STEM Education. This consolidation should make better use of resources and combat low productivity.
b. At the request of the Department of Textiles and Apparel, Technology and Management, a proposal to establish a dual degree partnership with Zhejiang Science and Technical University (presented by Dr. Yingjiao Xu) was approved.

Dr. Harries explained that this is not a $3+X$ program like the several that we have seen and approved recently. Students in this program will actually receive two degrees.

Dr. Xu explained that ZSTU is a current partner of NC State with several $3+X$ programs. Several faculty members have visited ZSTU, the research areas are similar and suitable for collaboration. This is a 3-year program. The first year would be courses at ZSTU. NC State faculty members will teach 4 courses at ZSTU, and ZSTU will cover the cost of these faculty members. Students will come to NC State for the second year of the program. The third year will be at ZSTU. Dr. Xu explains that there are benefits for both NC State and ZSTU for participating in this program.Dr. Xu explained that there is a high interest among faculty at NC State to teach those courses at ZSTU.

Ms. Adhikari asked about the student experience and possible cultural shock for traveling to NC State. Dr. Xu explained that the college already has a high number of international students so have resources available for these students.

Dr. Bowles explained that Ms. White passed away over the summer from cancer. The college supports the request.
b. Discussion of best practices for co-authored work in dissertations (presented by Dr. Alun Lloyd).

Dr. Harries introduced that this topic has arisen several times in various instances and that it is an important issue for consideration.

Dr. Lloyd explained that the way people are working on dissertations has evolved over the years. At other universities, collaborative projects are required to include a statement of the work responsibilities included in the appendix of dissertations and final projects so that it is clear who is responsible and who gets credit for the work.

The Board discussed that it is the responsibility of the advisory committee to examine the dissertation and ensure that the work of the student is presented in the dissertation. Dr. Harries noted that committees may be making different determinations, so perhaps we could create guidelines for committees to follow.

The Board suggests looking at other Graduate Schools to see if other schools have established guidelines or best practices for inclusion of work. The Graduate School will work on collecting research about this.

## IV. Information Items

a. Report from Graduate Student Association (GSA) (presented by Ms. Urmila Adhikari).

Ms. Adhikari will be the GSA representative for the Fall 2018 semester. She is a Plant Pathology doctoral student and a member of the Research Recognition Committee in GSA.

She reports that a goal of GSA this year is a mental health initiative for graduate students. They are working with the Graduate School, Student Health, and Student Government on this initiative. This is still in the beginning stages and she hopes to have more updates soon. The Board is enthusiastic and interested about this initiative.

She reports that the GSA constitution was amended to include a statement about minority populations. They awarded their travel and conference awards and are working on compiling a list of travel awards available to graduate students.
