### FINANCIAL GUIDELINES

Please complete the following form and upload it with supporting financial documentation and a copy of your passport to your online application. Your application will be incomplete and we will be unable to proceed until this form and the supporting documents have been received.

You must document sufficient funds for the Intensive English Program (IEP). We will accept a personal bank statement or letter which demonstrates the exact amount of liquid assets currently on deposit in the account. If you are not using personal funds, please indicate how you will be supported in the space provided in Section II below, listing a relative, friend, employer, government or institution funding, and submit their financial documentation in the form of a BankStatement or Letter.

You are required to submit proof of funding for one full academic year, even if you will take less time than that to complete the IEP program. If you matriculate into a full-time graduate program at any point, you will be required to complete a new CFR for your new program.

### The Bank Statement OR Bank Letter:

- -Must certify that the money is currently on deposit in liquid assets.
- -May include checking or savings accounts, certificate of deposits, or money market accounts. However, value assessments of properties or stocks/investments, salary information, mortgages, etc. are not acceptable.
- -Must be in English or translated to English.
- -Date of issuance must be clearly listed on the document and be within last 6 months.
- -Bank letters must include the printed name, job title, stamp, and original signature of a bank representative.

Applicants who will be financially sponsored by his/her employer, home government or university must provide an Official Letter of support from the scholarship or fellowship source with the current date and a signature indicating the amount and duration of the award. The letter should also include the applicant's name and state that it is valid specifically for enrollment in the Intensive English Program.

<sup>\*\*</sup>Please keep in mind that this is an estimate calculated well in advance of the actual start of the semester and these estimates are subject to change. An increase per year of 2-5% can be expected. Students should not expect employment, either part-time or full-time during the summers, to be a significant means of support. Please note that applicants will need to submit another CFR for the degree program when they are ready to move into the master's or PhD program after completion of the IEP program. Program costs vary.
