#### III. Continued Business

a. Internship Courses – Liability Insurance Requirement in Descriptions (presented by Jody Sykes)

Jody Sykes, on behalf of the Cashier's Office, presented more on the Liability Insurance Requirement from the previous meeting discussion to give a clear understanding of what the blanket insurance will cover. This insurance is to protect both the student and the university while the student is working out in the field, whether business or medical field, in cases where the student will be receiving credit hours for their work. It prevents students from overpaying outside insurance companies for mandatory employer insurance. Members of the Administrative Board of the Graduate School (ABGS) will be sent an excel spreadsheet to review containing courses marked with a liability insurance attribute by Registration & Records. It was suggested that members should also tag any courses that may need the insurance on a case-by-case basis.

b. Best Practices Document (presented by Dr. Peter Harries)

The "University Course Process Best Practice Document" continued discussion focused on whether or not the Graduate School process would mirror the undergraduate process. It was discussed that though the Best

Practices Document was a great guide, there were still questions about what would be needed to process graduate courses, and whether or not a course syllabus would be needed to supplement course proposals in CIM. In order to make a decision about whether or not the ABGS will honor the document for the graduate course process, Dr. Harries suggested that members should evaluate the Syllabus Regulation to determine what should be mandatory for a syllabus submission at the course proposal front. The Syllabus Regulations documents – one mark-up version and one final version – will be distributed to the ABGS members with the next meeting agenda, and members are expected to evaluate both documents for feedback in the next meeting.

#### IV. New Business

a. Graduate School Representative (GSR) Role on Committee (presented by Dr. Peter Harries)

Dr. Harries proposed the creation of a video to provide new GSR's information, expectations, etc. about their role. The decision on the proposal was agreed upon unanimously, and Dr. Harries will present a rough script of the video topics at an upcoming.
