Health Insurance Rates (NCSU RA-TA Plan) | 2021-2022

Policy Year: August 1, 2021 – July 31, 2022

Monthly Premium: \$225.12

Annual Cost: \$2,701.44

Effective August 1, 2020, the annual premium for graduate student health insurance (GSHI) on the NCSU RA-TA plan (Graduate Student Support Plan) for the 2020-2021 policy year is \$2,701.44. Please note that eligibility for coverage/participation on the NCSU RA-TA plan is assessed each semester (Census Day), and so, the coverage premium is paid on a semester basis at \$1,125.60 (Fall) and \$1,575.84 (Spring).

Health Insurance Rates (NCSU RA-TA Plan) | 2020-2021

Policy Year: August 1, 2020 – July 31, 2021

Monthly Premium: \$218.30

Annual Cost: \$2,619.60

Effective August 1, 2020 the annual premium for graduate student health insurance (GSHI) on the NCSU RA-TA plan (Graduate Student Support Plan) for the 2019-2020 policy year is \$2,619.60. Please note that eligibility for coverage/participation on the NCSU RA-TA plan is assessed each semester (Census Day), and so, the coverage premium is paid on a semester basis at \$1,091.50 (Fall) and \$1,528.10 (Spring).

Previous Year RA-TA Plan Health Insurance Rates

Health Insurance Premium for 2019-2020

Effective August 1, 2019 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$2,503.80 per GSHI year (8/1-7/31). On a monthly basis the premium is \$208.65.

Students eligible for the Graduate Student Support Plan have this premium paid at no cost to the student as a benefit of their assistantship or fellowship.

Health Insurance Premium for 2018-2019

Effective August 1, 2018 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$2,249.76 per GSHI year (8/1-7/31). On a monthly basis the premium is \$187.48.

Students eligible for the Graduate Student Support Plan have this premium paid at no cost to the student as a benefit of their assistantship or fellowship.

Health Insurance Premium for 2017-2018

Effective August 16, 2017 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$2,150.52 per GSHI year (8/1-7/31). On a monthly basis the premium is \$179.21.

Students eligible for the Graduate Student Support Plan have this premium paid at no cost to the student as a benefit of their assistantship or fellowship.

Health Insurance Premium for 2016-2017

Effective August 16, 2016 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$2,106.12 per GSHI year (8/1-7/31). On a monthly basis the premium is \$175.51.

Students eligible for the Graduate Student Support Plan have this premium paid at no cost to the student as a benefit of their assistantship or fellowship.

Health Insurance Premium for 2015-2016

Effective August 16, 2015 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$2,004.00 per GSHI year (8/16-8/15). On a monthly basis the premium is \$167.00.

Students eligible for the Graduate Student Support Plan have this premium paid at no cost to the student as a benefit of their assistantship or fellowship.

Health Insurance Premium for 2014-2015

Effective August 16, 2014 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$1,937.64 per GSHI year (8/16-8/15). On a monthly basis the premium is \$161.47.

Students eligible for the Graduate Student Support Plan have this premium paid at no cost to the student as a benefit of their assistantship or fellowship.

Health Insurance Premium for 2013-2014

Effective August 16, 2013 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$1,937.64 per GSHI year (8/16-8/15). On a monthly basis the premium is \$161.47.

Students eligible for the Graduate Student Support Plan have this premium paid at no cost to the student as a benefit of their assistantship or fellowship.

Health Insurance Premium for 2012-2013

Effective August 16, 2012 the annual premium for Graduate Student Health Insurance (GSHI) under the Graduate Student Support Plan is \$1,705.68 per GSHI year (8/16-8/15). On a monthly basis the premium is \$142.14.
