Graduate Certificate Financial Aid

Good news! Graduate certificate programs now qualify for federal financial aid effective for the Fall 2021 semester! Students interested in receiving a federal loan to fund their graduate certificate expenses should visit studentaid.gov and complete a 2021-22 Free Application for Federal Student Aid (FAFSA). Upon receipt of the processed application, the Office of Scholarships and Financial Aid will evaluate their eligibility for federal loan funding. The Office of Scholarships and Financial Aid office will make contact with students by email. Admissions

Be sure to wrap up your fall 2021 applications that are still pending a department decision. Classes begin August 16th, so fall applications should be processed prior to the term start date. If your program is full, pending applications should be denied or moved to a future admit term (this can be accomplished by sending an email to graduate_applications@ncsu.edu).

Likewise, if your application is still available to applicants for fall 2021, but you are no longer accepting new students for the term, please email Lindsay at lwgentil@ncsu.edu, and request to have your application cycle closed for the term.

Course Registration - Fall 2021

We tend to see an increase in schedule revision forms at the beginning of the term. These are mostly from students who "forgot" to register, or didn't know they had to register for the term in which they defend. Please ask your students to check their schedules and make sure they are registered properly prior to census day, Aug. 27th.

Residency

Residency determination is handled through the NC Residency Determination Service (RDS); note that students should only submit an RDS application after they have been physically present in NC for one full year or longer. Additional information is available at go.ncsu.edu/NCRes.

It is imperative that new out-of-state students, who intend to apply for in-state residency in Fall 2022, begin their residency acts as soon as they arrive in NC. Some examples of residency acts include getting a NC driver's license, registering to vote, registering a vehicle, and further actions which demonstrate ties to NC.

Advanced Enrollment Deposits

As a reminder, if your graduate program requires an enrollment deposit, September 1 is the <u>deadline</u> to request a deferment of the enrollment deposit for students deferring from 2021 admit terms.

Graduate Assistantships

Auto-Term for Summer '21 Appointments Ending 8/15

For August 15th appointment end dates, the auto-term ran on July 28th. All modifications that <u>were not</u> successfully processed prior to July 28th will need to be deleted in NextGen and then re-entered as either a new grad appointment or rehire. Auto-Term rows are run each Wednesday night, three weeks prior to the expected appointment end date. The current Auto-Term schedule can be found <u>here</u> and is updated regularly.

The 2021-2022 Bi-weekly and Monthly Payroll schedules are now available and can be accessed via the University Controller's Office website for Payroll Coordinators here.

Payroll Deduction for Student Fees (Fall 2021)

GSSP-eligible graduate students on active graduate assistantships may request payroll deduction for student fees. This option is available to eligible students through their Student Accounts tile within *MyPack* portal *until* August 27. This option is not available for fellowship recipients. Graduate students must meet the following criteria to participate:

- Have an active graduate assistantship in the HR system that begins on or before Census Day. The assistantship must extend, at least, 30 days beyond the first day of classes.
- Must be appointed to a GSSP-eligible position as described on the <u>Graduate School GSSP website</u>.

- Must select the payroll deduction option by Aug. 27.
- Must be enrolled full-time (i.e. 9+ credit hours); this option can only be used for students with full-time fees only.
- Must have a GSSP tuition "Do Not Cancel Enrollment" service indicator for Fall 2021 added to their account. Departments can add these service indicators manually and are encouraged to do so (see Manage Service Indicator Instructions). Note: The "Authorize Payroll Deduction" option will not appear on the Student Accounts tile until after the service indicator has been entered.

Payments will be deducted from the student's stipend beginning with the first "full" biweekly paycheck on September 17, over six pay periods. Students who do not want the deduction should email studentsaccounts@ncsu.edu. If the assistantship is terminated, however, any outstanding balance in fees must be paid in full. The payroll deduction is completely optional.

Recruitment Initiatives & Innovation Grant
