New EIN Requirement on SSN Offer Letters (F-1 Students)

As you may know, the Social Security Administration (SSA) has a new requirement to include the Employer Identification Number (EIN) assigned to NC State on offer letters used by the F1 students to receive a social security number. The Graduate School became aware of this issue recently and collaborated with the EAS team to update the Graduate Assistant Terms and Conditions (T&C) letter generated within the Next Gen hiring system to include the NCSU EIN number. A welcomed change alongside the EIN requirement is that SSA is no longer requiring a "wet ink" signature on any document.
