## III. New Business

- a. New degree program process (Helen Chen) A new, streamlined approach to new programs was presented that should accelerate the ability of NC State to develop and launch them more quickly. To facilitate this a number of steps were outlined in an attempt to reduce the time to under two years.
- b. Planning for the Supreme Court decisions on the admissions cases (Peter Harries) Currently there are two admissions-related cases that have been argued before the Supreme Court involving Harvard University and UNC-Chapel Hill. The decisions are expected to be announced some time during the Summer, likely in June. At this point, it is unclear to what extent the current approach will be altered, but the Graduate School has been working with the General Counsel's Office to initiate the review of our applications.
- c. Suggestions from the Mental Health Task Force related to the Grad Handbook (Peter Harries) One of the elements that is contained in the document generated by this committee is a move to evaluate not only Policies, Regulations, and Rules (PRRs) of the university, but also the Graduate Handbook. There have been a number of suggested changes that are currently being initially reviewed by the Graduate Student Issues Task Force.
- d. Students switching advisors and terminating of grad appointments (Peter Harries) An on-going issue that has become more acute during the pandemic is students suddenly learning that their progress is deemed unacceptable, and they are then losing support with very little warning. This can be especially

impactful for international students, especially those who are unable to find other sources of funding/support. The thought is that we need to develop a more deliberative approach to this and to give students earlier warning as well as a reasonable improvement plan in an attempt to get them back on track.

## IV. Information Items

- a. Report from Graduate Student Association (GSA) (presented by Ms. Echo Pan) The in-coming president will be Margaret Baker, a PhD student in Communication Rhetoric and Digital Media. Also, the decisions are being made for the conference travel grants for the Spring semester.
- b. Report from Faculty Senate (presented by Dr. Tamah Morant) People were encouraged to become candidates for the up-coming election to the body.
