- b. <u>Stacking credentials</u> policy (Peter Harries). Peter Harries shared the stacking credentials policy and informed the committee that it is in the process of being added to the Graduate Handbook. The committee discussed if the policy should apply to just Master's or if the Doctoral programs should be included.

- a. Report from Graduate Student Association (GSA) (presented by Naimul Haque) The GSA had their all council meeting and they had Doug Morton as a guest speaker. They also discussed their constitution and had some changes and discussed the transportation fee increase. They have formed their internal committees and started the travel grant application process.
